

## **Code of Conduct for Spectators**

Crusaders FC wishes to create a welcoming, safe, family environment at Seaview<sup>i</sup>. We also hope for a passionate, raucous and sporting atmosphere that encourages the team. We encourage applause, cheering and non-abusive singing that will have a positive influence on the atmosphere and can contribute to the enjoyment and outcome of the match.

Crusaders FC are proud of its supporters and their good behaviour and the passion and support they show for their team. The Club will, however, take steps to prevent people from behaving in a manner likely to jeopardize the safety and enjoyment of others, or to bring discredit on the club.

We are mindful of our obligations under the Northern Ireland spectator behaviour legislation and support the IFA's "Football for All" programme, the UEFA 10 Point Plan and the "Let's Kick Racism Out of Football" campaign against indecent, sectarian or racist chanting or behaviour. Any supporter who publicly disparages, discriminates against or denigrates someone in a defamatory manner on account of race, colour, language, religion or community affiliation, ethnic origin, gender or sexual orientation may be summarily evicted from the ground and face further sanctions. In the case of members, they will be subject to investigation. If a crime has been committed, the offence will normally be reported to the police. This includes the display of offensive banners.

If you or your fellow supporters hear any abuse of this nature, then please report it to the nearest steward or club official.

## Supporters must refrain from:

- using sectarian, racist, homophobic, sexually offensive or any other inappropriate language;
- violent conduct;
- the display of any racist or sectarian emblems or banners;
- Using foul, abusive or insulting language, gestures or threatening behaviour to anyone including players, team officials, match officials, Club officials and stewards or other supporters;
- throwing missiles of any sort
- entering the any part of the playing surface;
- behaving in a manner likely to jeopardise the safety and enjoyment of others;
- consume intoxicating liquor to such an extent that s/he is a nuisance to others and a danger to himself and others.

## Supporters should:

- respect all players, team attendants and match officials;
- follow directions and instructions given by stewards and club officials;
- respect the supporters of other teams;
- report breaches of our code to a steward or club official;
- remember to observe the code both at Seaview and at away games;
- support Crusaders Football Club loudly and proudly and in a manner that offends no-one.

All fans should note that under legislation relating to Spectator Behaviour at Sporting Events there are several activities which are deemed to be offences and can lead to fines, imprisonment or a football banning order.

- Throwing an article capable of causing injury can attract a fine of up to £1000
- Indecent or sectarian chanting can attract a fine of up to £1000
- Going on to the playing area can attract a fine of up to £1000
- Possessing fireworks or flares at a match can attract a fine of up to £1000 or a prison sentence of up to three months.
- Possessing alcohol on private hire vehicles on the way to sporting events can attract a fine of up to £1000 and/or a prison sentence of up to three months and the vehicle operator can also be fined up to £2500.

Visiting supporters are also to respect our Code of Conduct. All supporters should note that observing the Code of Conduct is a condition of your entry to the ground. Any person not observing the Code may be refused entry to the ground or ejected and face further sanctions.

In the event that a supporter breaks the code, they may be immediately ejected from Seaview and refused entry to future matches. The Board will consider the circumstances and if the supporter is a member, the Board may use its power to suspend or expel the member from membership. The member may appeal to the Disciplinary Panel who may investigate. The member may. if not already suspended by the Board, be suspended by the panel until investigations are complete. The member may also appeal to the Executive Committee.

Subject to ratification by the Board, a member subject to disciplinary sanction will forfeit membership with immediate effect. No member who has been suspended may re-apply for membership. Re-admission to Seaview as an ordinary match-per-match non-member or paying supporter/customer can only occur after their suspension ends. Admittance of non members to "Seaview" is at the discretion of the Safety and Security Officer in accordance with the Rules and Codes of Conduct of the Club.
